# Appendix A

**Tradition 4:** "Each group should be autonomous except in matters affecting other groups or AA as a whole."

There's a recurring theme running through AA's steps, traditions and the concepts for service: the movement from chaos to a spiritual solution that provides balance and equilibrium.

In the early days of AA, prior to the adoption of the traditions, new groups formed wherever AA's relocated. It was truly a trial-and-error free-for-all in terms of membership requirements, meeting structure, affiliation with outside entities, and with promotion. For example, one group in Virginia actually served beer at their meetings. They wanted to attract lots of members, and they were focused on keeping people off the "hard stuff." As there were no traditions or guidelines for groups, even they were not disqualified from calling themselves an AA group. Bill wrote, "...every conceivable deviation...has been tried. That was sure to be, since we are so largely a band of ego-driven individualists. **Children of chaos**, we have defiantly played with every brand of fire, only to emerge unharmed and, we think, wiser." It seems we, as alcoholics, individually or in groups, are driven to exhaust those ways which do not work before accepting that which clearly does work. Experience has demonstrated that eventually groups will come to rely on the basic principles of their primary purpose—to serve those who still suffer.

This tradition is a testament to **AA's great faith in an inspired group conscience**. A.A. is so certain of this that each group is regarded as an individual entity governed only by its group conscience, so long as it doesn't affect neighboring groups or A.A. itself. So it is **that every group has the right to be wrong**.

**Concept 4**: Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge.

In English, this means that AA Trustees, the Directors of the service corporations—AA World Services, Inc. and The AA Grapevine, Inc.—together with their executive staffs, shall always be voting members of the General Service Conference. So, every year when all the Areas send their delegates to the GSC to be our voting representatives, these other folks also are able to vote even though they do not represent any AA area. Who are they?

Trustees—alcoholic and non-alcoholic chosen to lead such a large organization as AA.

Directors—also People with expertise in some relevant aspect of running AA, chosen by the Trustees to sit on the two service boards directing AA's services.

Executive staff—paid employees of AA who carry out the directions and do the actual work.

Each of the two service boards, World Services and the Grapevine, have a mix of all three of these types on their boards, and each has an equal **vote**, and therefore, **participation**.

This idea of staff representation on the boards actually has its roots in a dispute about Easter bonnets. [Related story of issued paychecks getting ripped up because the director of the New York AA office didn't like paychecks getting written early so that female employees could buy Easter bonnets. Bill W. was not pleased.]

Bill W. - "Every time an absolute authority is create it always invites this same tendency toward over-domination respecting all things, great and small."

When it comes to the GSC, it gets more controversial. Nearly every conference, some delegates want to take away the right of trustees, directors and staff to vote at the Conference because they do not represent AA groups.

Finally, Bill comes to the spiritual angle: "everyone has the right to belong". There are no members who are regarded as "second class". "Deep down, I think this is what we have been struggling to achieve in our world service structure. Here is perhaps the principle reason why we should continue to ensure "participation" at every important level. Just as there are no second-class AA's, neither should there be any second class world service workers, either."

An A.A. member who might cringe if I called him a mentor says of Step 6 & 7, "This is where we decide what sort of person we want to become, and then begin the work of becoming that person." He gives an important reminder that no one ever really completes this step; that it marks the beginning of a journey rather than an end in itself.

For me, this step is emblematic of the entire A.A. program of recovery as a new and better way of living--not as a quick cure for addiction. Perhaps the most dangerous words one can hear in A.A. are, "I've <u>done</u> the Steps." I sincerely hope I never think I am done growing by and through applying the Steps to daily living.

The character defects we seek to lose in Step 6 are self-defense mechanisms necessary to support a life run on self-will. They are useless and incompatible to lives we seek to live by God's will. So why do we still cling to them? Is it because deep down we harbor the idea that we weren't really all that "bad" or all that alcoholic? Do we think we can get along well enough with just a little A.A.?

Here is how Bill W. closed his essay on Step 6: "Delay is dangerous, and rebellion may be fatal. This is the exact point at which we abandon limited objectives, and move toward God's will for us."

## ...on TRADITION #6

"Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual."

A.A. Tradition Six, Long Form

In A.A.'s early years, groups and individual members sought business relationships, endorsements and all manner of entanglements with entities outside of A.A. itself. Today, it's likely the only outside body with which an A.A. group may have dealings is a club or meeting house which hosts the group's meetings. This simple tenant/landlord relationship can be fraught with complications in terms of money, blurred boundaries, and hard feelings. It seems that even in recovery, alcoholics can find relationships challenging.

In a local town, A.A. members pooled their resources years ago to purchase a small former church building to serve as a meeting place for recovery meetings. They incorporated as a non-profit organization, with all control in the hands of the members of the groups renting meeting space in the building; all members of the board of directors are elected from the memberships of those groups. Here is where some folks get confused: as individuals who regularly attend recovery meetings at the club, they are collectively, in fact, *the landlord*; as members of an A.A., Al-Anon or other group assembled in a recovery meeting, their group is *a rent-paying tenant*.

Somehow, this apparently split personality has worked pretty well for quite some time. There are discussions around questions of funding for everything from coffee to furniture, medallions to building improvements. Those members willing to serve as board members sometimes need thick skin, and a firm grip on the Serenity Prayer. It sometimes brings to mind a quote from Bill W., "Within A.A., I suppose, we shall always quarrel a good bit. Mostly, I think, about how to do the greatest good for the greatest number of drunks...Surmounting such problems, in A.A.'s rather rugged school of life, is a healthy exercise."

## A.A. Service View

"Sponsorship is a bridge to trusting the human race, the very race we once resigned from. In learning to trust, we are strengthening our sobriety."

Bill W. always considered Ebby T. to be his sponsor, even though at the time of their seminal talk at the kitchen table there was not yet anything we now know as A.A. When Bill met for the first time with Dr. Bob they, too, met as equals: It was simply one alcoholic talking with another, sharing their recovery experience.

There is no Sponsorship College in A.A.; no conference-approved checklist for guiding a newcomer to a new way of life. There is one alcoholic with experience in A.A.'s 12 Steps of recovery sharing that experience with one alcoholic trying to gain or maintain sobriety in A.A. Styles of sponsorship may vary from member to member. I personally try to tailor my sponsorship to the individual sponsee, but in each case the emphasis on the Steps remains the same. I do my best to convey to him all that has so graciously been given to me.

I don't think I am the right sponsor for every newcomer. I am the right sponsor for some, and I think every experienced member is just the right sponsor for someone. I believe God blesses sponsorship. I also take great comfort that in A.A. there is an unbroken sponsorship line from my sponsor back to the founders: one alcoholic sharing their experience, strength and hope with another.
