Members' Views

...on STEP #10

"For the wise have always known that no one can make much of his life until self-searching becomes a regular habit, until he is able to admit and accept what he finds, and until he patiently and persistently tries to correct what is wrong."

--*Twelve Steps and Twelve Traditions*, pg. 88 I cannot stake a claim of wisdom for myself, most certainly not yet. Nor am I yet well-skilled at selfrestraint in talk or action; for my quick temper, honed by a lifetime of prideful self-justification supercharged by fear, is sure to take much time and concerted counter-action to overcome. That's why an alcoholic like me needs to make a persistent, daily practice of Step Ten.

Bill W.'s reminder, "It is a spiritual axiom that every time we are disturbed, no matter what the cause, there is something wrong *with us.*" cuts me to the quick every time I am reminded of it, for it's a rare day that I don't get disturbed by something or by someone's actions. The old and very helpful advice to "count to ten" before reacting to such a disturbance provides me the time to reach for Step Ten, and hopefully to avoid creating yet another need to make an amend.

I have been more successful thus far in my A.A. program at adopting the end-of-day Step Ten inventory. In fact, I find this practice to be calming, spiritually rewarding, and a perfect way to "put the day to bed." Yes, each day there are failings to acknowledge and motives to examine. But there are also some things I've done pretty well, and they, too, merit attention. My evening Step Ten is how I learn about myself in recovery today, because surely the best way to tell *how I'm doing* is to look at *what I'm doing*. My evening Step Ten also stimulates humility and a need to go directly into Step Eleven before gratefully retiring for the day.

"Therefore it is evident that the harmony, security, and future effectiveness of A.A. will depend largely upon our maintenance of a thoroughly nonaggressive and pacific attitude in all our public relations." --Twelve Concepts for World Service, pg. 67

A.A. was born amid the turmoil and suffering of the Great Depression. Internationally, fascism was on the rise and sabers were being rattled. A controversial U.S. president was seen as a savior by many, but as an existential threat to the Constitution by others. Now eighty years on, and the more things change and the faces change, the more they stay the same: nations and factions grasping at one another's throats.

Then as now, inside of A.A. noisy squabbles raged over questions of anonymity, group management and money—always about the money. For the alcoholic members of A.A., however, these internal arguments were largely over how best to serve the still-suffering ones, and how best to preserve the new fellowship. Historians tell us there's never been a serious civil war within A.A.

In my own experience, I can think of only two instances of a member bringing outside issues into the rooms of A.A. In both cases, the more senior members quietly let it be known that such demonstrations are most unwelcome. I have known some members for years, and have not the least idea of their political or cultural leanings or outside affiliations. In an A.A. setting these questions are irrelevant. What a blessing! If A.A. was not a haven from the messy noise of society at large, how differently would I value my membership?

Do A.A. members exercise personal opinions on outside issues? Of course they do, as do I. But in recovery, the Big Book cautions us to cease fighting anyone and anything.

Remarkably, Tradition Ten extends this same warning to all of A.A.: As Bill W. phrased it in his essay, "As by some deep instinct, we A.A.'s have known from the very beginning that we must never, no matter what the provocation, publicly take sides in any fight, even a worthy one." For the fellowship as well as for the individual alcoholic, this is a matter of self-preservation.

A.A. Service View

The Cleveland Contributions to A.A.

"The early Cleveland experience of Alcoholics Anonymous was different, at times weirdly so."

--Ernest Kurtz, Not-God, A History of Alcoholics Anonymous, 1979. Published by Hazelden. Cleveland, Ohio was the first city where the early growth of A.A. was not dominated and personally lead by a co-founder. As a result of this 'orphan' status, and aided by early positive publicity, A.A.'s in the city were impelled by the pressures of rapid growth to create for themselves three bedrock principles of A.A. service that we take for granted today.

The first A.A.'s in Cleveland got the program from Dr. Bob S. in Akron. Following the arrival of the Big Book in 1939, they became the first "A.A. laboratory" for independent group formation and management. Groups formed, grew and split rapidly. Soon all close interconnections among the original members became diluted. Leaders quickly grasped that rotating committee membership, based solely on length of sobriety, was the only hope of keeping everyone in touch and involved. Thus they invented the concept of the '*spirit of rotation*.'

At the same time, as new groups metastasized at a rate that far outpaced the establishment of personal relationships, their committees realized they must make decisions based solely upon A.A. principles rather than personal preferences. Born of necessity, the concept of *'principles before personalities'* became the standard. This concept has the inherent benefit of building loyalty to the A.A. fellowship instead of dependence upon, and deference to, any individual members.

The third A.A. concept, and perhaps the most crucial, that first arose in the flood of growth in Cleveland in the early 1940's is the formalization of the tradition of '*sponsorship*.' This was the only means by which

they could help such large numbers of newcomers to the program while at the same time satisfy the need of current members to 'keep it by giving it all away.'

While New York and Akron share A.A. fame as the places 'where it all began' under the co-founders, we owe a debt of gratitude to the early A.A. pioneers of Cleveland, whose pragmatic solutions to the challenges of runaway expansion of the fellowship have given us concepts of A.A. service that continue to serve us well today.

Next Orientation Probably in **October** So Get Your Application In Now!

Due to life changes and other factors, our number of volunteers has diminished. In order to keep up with the schedule of meetings we need more volunteers, **especially women**.

The District 05 Corrections Committee recommends a minimum of one full year of sobriety and that you have worked the 12 Steps with a sponsor.

The jail staff will approve or disapprove a volunteer based on the following guidelines:

- The volunteer is not currently on probation.
- Has been off of probation for over a year.
- Has not been in the Eau Claire County Jail for over 3 years. Including weekend stays
- Does not have any active cases going thru the court system.
- Is an "active member" of society (has been working, has a place to live)
- Pass the background check
- The easiest way to sum up everything is, each volunteer needs to be off probation, has not been arrested, or been in the Eau Claire County Jail for the last 3 years, and does not have an open case within the last 3-5 years.

Service position open for Corrections Committee

(And you don't need to go to jail!)

The Corrections Committee for AA District 05 needs a person who is organized and can use a computer to schedule people to go into jail meetings. This person does <u>not</u> need to qualify to take meetings into correctional facilities.

The scheduler takes a list of volunteers already qualified for meetings, applies the volunteers' stated preferences for days they are available and puts the names on a calendar. This is done once every 3 months.

Requirements are at least one year of sobriety, access to a computer and have an active email account, since much of our correspondence is done via email. (Familiarity with a program using calendar functions can be taught. Many easy, free programs are available so the person does not need to have that on their computer right now.)

Perfect opportunity for someone who wants to be of service to alcoholics, but does not want to go into jails, or does not qualify to go into correctional facilities.
