- o A. Consider proposed revisions to *Alcoholics Anonymous*:
 - 1. Request to add an appendix reflecting recognition received from the Library of Congress. Vote: Yes.
 - 2. Request to add the A.A. Preamble and Responsibility Statement. Vote: Yes.
 - 3. Request to add an endnote to Bill W.'s story acknowledging co-founder, Bob S. Vote:
 Yes.
- o B. Consider request that A.A. (U.S./Canada) publish "The God Word" (a pamphlet currently published by the General Service Board of Alcoholics Anonymous, Great Britain). **Vote: Yes.**
- o C. Consider request for the development of a pamphlet for atheist and agnostic members. **Vote: No.**
- o D. Consider request for the development of a pamphlet based upon A.A.'s Three Legacies. **Vote: Yes.**
- o E. Review report and suggestions on the inclusion of language related to safety in A.A. literature. **Vote: Did not review in the interest of time.**

- o J. Review progress report and draft revised text for the pamphlet "The Twelve Traditions Illustrated." **Vote: Did not review in the interest of time.**
- o K. Review progress report on the update to the pamphlet "Too Young?" **Vote: Did not review in the interest of time.**
- o L. Review progress report on the update to the pamphlet "Young People and A.A." **Vote: Did not review in the interest of time.**
- o M. Consider request for revision to Living Sober. Vote: Yes.
- o N. Consider request for the development of a new book combining Twelve Steps and Twelve Traditions with Twelve Concepts for World Service. **Vote: No.**
- o O. Consider request to update the video "Your A.A. General Service Office, the Grapevine and the General Service Structure." **Vote: Yes.**
- o P. Consider request to change the subtitle of the pamphlet "G.S.R. General Service Representative: May Be the Most Important Job in A.A." **Vote: Yes.**
- o Q. Consider request for the development of a new pamphlet for Spanish-speaking women alcoholics. **Vote: Yes.**
- o R. Consider request to add a section on anonymity to the pamphlet "Questions and Answers on Sponsorship." **Vote: Yes.**
- o S. Review matrix of A.A. recovery literature. Vote: Did not review in the interest of time.

• Report and Charter

- o Suggested changes to Service Manual. Nothing controversial.
- o Discrepancies between *Service Manual* and "The AA Group" pamphlet, so suggestion made to perhaps just refer to the pamphlet instead.
- o Use of the circle and triangle symbol has been discontinued, so the can be removed from any literature on which it appears.
- o AA Directories: Not used much and they get out of date quickly, so agreement they would be better online.
- o Do discussions need to be published in entirety? **Vote: No.**

• Treatment and Accessibilities

- o More should be done to address those in active military service to make sure AA is there. **Vote: Agreement that exploration should continue.**
- o "Accessibility for All Alcoholics" (pamphlet):
 - Accessibility has wide range of meanings: Mental illness, remote communities, cultural/language/geographical barriers, etc.
- o Carrying the message to deaf and hard of hearing members:
 - A person is struggling locally to be part of AA due to this.
 - Proposal to have ASL at Area conferences and assemblies.
 - Who is responsible for funding?
 - Vote: Delegate should advocate for more information.

Trustees

- o Original Alcoholics Anonymous manuscript was up for auction:
 - General Service Board went to court and seized the document, stating it belongs to AA.
 - Concern: Why didn't they contact delegates somehow prior to filing the injunction?
 Controversial.

- Suit was dropped.
- Settlement: \$135,000 to cover cover legal costs to make amends with party that was sued.
- Should we censure the General Service Board? Vote: We don't have all the information to determine if GSB had all the information before their decision. Delegate can make decision based on the facts provided.

Archives

- o A. Review a draft proposed publication, *Our Great Responsibility: A Selection of Bill W's General Service Conference Talks*, 1951-1970
 - No copy of draft publication to review (security reasons and control of copyright.)
 - That has changed, draft items used to be available for review.
 - What are the costs? What format and what and how many pages?
 - It was thought there was an advisory action that all proposals that have a financial cost associated with them, that that cost should be included.
 - Vote: We are generally in favor. We need more information to make an informed decision.
- o B. Consider request from the AA Grapevine Board to post the 2017 General Service Conference presentation, "AA Grapevine and La Vina" on AA Grapevine's YouTube Channel.
 - Did the Grapevine sign a waiver on the presentation that gave Archives the copyrights to the presentation that was given by the Josh E, Grapevine Director?
 - The question is, do we trust the Trustees Committee and the Archivist to do the right thing?
 - Reference the 2013 Advisory Action in the background material.
 - This seems silly. We are the same group.
 - Does this help the next suffering Alcoholic?
 - Vote: We are generally for it.
- o C. Consider developing a policy on distribution of audio recordings of General Service Conference presentations.
 - How are the PowerPoint presentations handled and who owns the rights to the presentations?
 - Needs to be anonymity protected.
 - Are all recordings of the GSC automatically "owned by the AAWS" then sent to archives?
- o D. Review Archives Workbook
 - Vote: No recommended change.

• International Conventions and Regional Forums

- o A. Discuss selection of cities to be considered as a site for the International Convention in 2030
 - Question: Why are we down to only 2 cities to consider? In 2000, we had 12 to consider.
 - Is there a problem on our end? Is the contractor influencing the decision making process and the communication process with the potential host cities?
 - The Areas are responsible for submitting host cities.
 - Trustees will select from 3 cities, the point for us is moot.
- o B. Discuss inviting up to 21 non-AA speakers to participate in the 2020 International Convention at AA's expense.
 - Vote: No objection. Status quo.
- o C. Discuss ways to encourage interest in Regional Forums and attract first-time attendees.
 - Lead by example and sponsorship direction.
 - More PI and CPC work. Aggressively pursue more press, radio, and social media for all of AA, including the GSO.

Old Business

• Discussion: Workshops

- o Shane S. and Beth E. led a discussion about workshops in District 05.
- o Thoughts that District 05 groups should host 3-6 workshops in 2018.
- o District 05 could lead off by giving a "workshop on workshops" to give tools groups need to make successful workshops. This would have to happen by about May.
- o The Secretary will send out a list of topics for potential workshops from Shane.
- o Agreement that we don't want to get caught in rut of old workshops.
- o **GSRs & Committee Chairs:** Bring this back to your groups/committees to discuss the potential of doing a workshop, ideas for a workshop in general, etc. (See Appendix A, below the minutes.)
- o Should we have a workshop on workshops? Good majority interested in that.
 - Subcommittee formed: Shane will lead. Members: Ken P., Marybeth S., Katie B-B., Paul Mc., Matt A., and Brittany B.

• Tradition and Concept Presentation

- o John B. presented on Tradition 2 and Concept 2.
 - Read Tradition 2.
 - AA is a spiritual entity and should operate as such.
 - GSRs are an important voice to connect to AA as a whole and get group conscience.
 - Read Concept 2.
 - Gave a rundown of the concept from the Service Manual and the "12 Concepts for World Service Illustrated" pamphlet.
 - The spirit of the AA traditions should be kept and work gets done through delegation.

Appendix A

Workshops in District 05

Background

District 05 does not currently have any workshops planned for 2018, according to the online calendar. It is crucial that we carry the message to the still suffering alcoholic and hosting workshops is one way to do that.

Recommendation

District 05 groups will host a minimum of 3-6 workshops in 2018 at locations throughout the district. The first workshop would be hosted by the District 05 group and potentially could be a workshop on the "how to's" for creating, organizing, and hosting a workshop. Essentially, this workshop would provide the tools that groups need to feel comfortable pulling a workshop together. This workshop would likely need to take place in May or June of 2018 if we want to achieve the minimum goal of 3-6 workshops yet this year in District 05.

Bring Back to Your Groups/Committees

At each group's next group conscience meeting and next committee meeting, the GSRs and committee chairs will be responsible for asking two questions:

- 1. Is our group/committee interested in hosting a workshop in 2018?
- 2. If so, what topic is the group interested in?

The expectation would be that the GSRs and committee chairs would come to the April 11 District 05 meeting with their group and committee decisions.

The internet has a variety of suggested AA workshop topics which are attached and can be used as a resource for discussion.
