# **Pride**

"For pride, leading to self-justification, and always spurred by conscious or unconscious fears, is the basic breeder of most human difficulties, the chief block to true progress."

--- Twelve Steps and Twelve Traditions, pg. 48-49

At the time my sponsor was leading me through the Steps, the 5<sup>th</sup> Step felt like the finish line of a marathon, and I was thrilled and gratified to cross it. I had so feared sharing my moral inventory with anyone that I delayed working on Step 4 as long as I could get away with it. As for basking in the glow of Step 5 before moving on---the Big Book gives us one whole hour to do so.

Steps 4, 5, 6 & 7 together form an assault team that roots out our ugly secrets and defects, and hangs them out in the open for us see, to see through, and to commit to changing with help from our Higher Power. In Step 6 we acknowledge those character defects which have had so very much to do with our past difficulties and which still bedevil us today. To paraphrase a line from the old comic strip "*Pogo*," we have met the enemy and know that he is

For this alcoholic, the chief character defect is pride, along with its running mate---that liar, fear. I think they are an inseparable pair. In small ways and large, pride can subvert and threaten any commitment to personal growth: It can suggest I skip a bit of my A.A. program today; it can adamantly insist I'm not really an alcoholic at all. Pride can erase good motives. It can deny responsibility for harms done to others, or to myself. It can poison relationships. It can be that voice that says, "I've done well enough." In regard to the Higher Power, pride tells me I am It.

Step 6 doesn't take up much space in the Big Book; great ideas often require few words. We can't begin to become free of our character defects until we recognize them for what they are; until we become truly ready to let them go; until we commit to a life-long process of actions taken to counter them in ourselves.

# **Bankrupt Idealists**

"We of Alcoholics Anonymous could not be all things to all men, nor should we try."

--- Twelve Steps and Twelve Traditions, pg. 157

Bill W. was a man who dreamed big. He freely admitted when telling his story that he had considerable problems with grandiosity. A.A's Tradition 6 very directly was crafted to counteract this tendency toward 'big ideas' that finds prevalence in many A.A. members, then and now---not only in Bill W.

In the essay on Tradition 6, alcoholics are described as "bankrupt idealists." "Nearly every one of us had wished to do great good, perform great deeds, and embody great ideals. We are all perfectionists who, failing perfection, have gone to the other extreme and settled for the bottle and the blackout." This description shouldn't surprise anyone who has spent considerable time on a barstool in the company of fellow regulars who wile away endless hours spouting their solutions to all the world's problems.

When newly freed from enslavement to the 'bottle and the blackout' through the A.A. program of recovery, it seems only natural that our former tendencies toward grand ambitions would once again begin to stir. We need this tradition to keep us in check. Can you imagine A.A. today without it? Of course, we would operate a tremendous chain of treatment centers. A.A. would be taught in all public schools. We would have lobbyists badgering every legislature in the land to pass our versions of sensible alcohol-related policies. There probably would be A.A. vacation properties, retreat centers and golf courses. Maybe A.A.-brand coffee! Anyone could increase the list ad infinitum.

Tradition 6 reminds us that A.A. must not be diverted from our primary spiritual aim: to be here for the alcoholic who stills suffers. That person must not be confused about what A.A. offers; nor can he or she have any questions about who else or what else we are involved with; nor about the source of our funding. We must not mix the material with the spiritual.

# A.A. & the Birth of Modern Treatment

"Paid workers would kill our good will with alcoholics. If we went into the hospital business, everybody would say it was a racket."

--- A.A. Comes of Age, pg. 145

Very early in A.A. history, Bill W. had a vision of A.A.-owned and operated hospitals for the detoxification and treatment of alcoholics. That dream never was realized for very good reasons: first, there was no money; more significantly, the fledgling membership of A.A., including Dr. Bob, didn't buy the idea. But certain realities soon forced A.A. members to confront an alarming situation: due to positive media coverage, A.A. was attracting increasingly large numbers of primarily low-bottom drunks. A.A.'s knew that such people could experience delirium tremens and die during withdrawal from alcohol, so they must have professional medical help to detoxify safely. The A.A. policy of working with alcoholics hospitalized for medical detox was already so ingrained that, as early as 1939, there was debate within A.A. whether someone could even become a member if they had not first been hospitalized.

Gaining access to hospital beds for alcoholics was extremely difficult. In the post-depression economy, hospitals were overcrowded. Alcoholics generally were viewed as moral degenerates who had brought their physical problems on themselves, while beds were needed for decent people who were "really sick." Besides, alcoholics were notorious for not paying their bills. Even worse, a drunk going through D.T.'s was not a spectacle anyone wanted to see, especially hospital staff. Such patients were loud, messy, and frequently violent. So, at first, Dr. Bob smuggled A.A. prospects into Akron hospitals for detox under a diagnosis of "acute gastritis."

The situation began to change in 1939 when Dr. Bob found a sympathetic ear in Sister Ignatia, who was the admitting clerk at St. Thomas Hospital. Together they formalized a regimented treatment program for alcoholics. It began in a tiny extra room previously used to store flowers as well as dead bodies awaiting the trip to a funeral home. It ultimately was expanded to a remodeled 8-bed ward, with all materials, labor and furnishings provided by A.A. members. Members also volunteered to work regular shifts as unpaid orderlies on the ward, cleaning up and dealing with unruly patients; more importantly, they provided companionship and a model of successful recovery from alcoholism.

Dr. Bob and Sister Ignatia created a model for treatment that soon spread to Cleveland, New York City, Philadelphia, and other cities as A.A. grew. Their model combined medical detox with intensive immersion in A.A.'s 12 Steps. Some key features of the program were copied in each new location.

- --The hospital was responsible only for the medical detox. All other matters were the responsibility of A.A. members; no other visitors were allowed on the ward.
- --Patients were responsible to welcome, care for and help orient newer patients. Treatment was defined as participation in a caring community. This practice was the beginning of their 'work with others.'
- --Each patient was admitted under the direction of an A.A. sponsor who had at least 1 year of sobriety. Actually the term 'sponsor' came into use because the A.A. member personally guaranteed payment of the hospital bill, (\$75 for 5 days) paid in advance. He likely was reimbursed later by the groups. The sponsor's role was key, according to Sister Ignatia, "The sponsor acts as a catalytic agent in combatting all adverse forces. He tries to appease an exasperated wife, talks with the employer, landlord, creditors, and others. He explains the program, tells them that this is not simply another 'sobering up process.'" The sponsor had a voice in the decision to admit the patient; he brought the patient in, led the A.A. training, and personally discharged the patient into his own care. In most cases, the patient was then taken to the home of an A.A. member. This was the beginning of the 'halfway house.'
- --Dr. Bob, always a man of few words, peppered his daily rounds on the ward with brief slogans still in use today, such as 'Easy Does It' and 'First Things First.' He personally saw to the care of nearly 5.000 patients. A.A. literature and other inspirational material was also an important part of the treatment. Sister Ignatia is credited with starting the tradition of tokens given as a milestone celebration. She also handed out books similar to today's *Daily Reflections*. She personally conducted an exit interview with each patient and sponsor.
- --Both Dr. Bob and Sister Ignatia detested their program being called 'the cure' and adopted the term 'treatment' to describe their efforts. They always stressed that there is no 'cure' for alcoholism.

This Akron model of treatment spread rapidly because it filled a pressing need and was successful in changing many lives. It also kept A.A. itself free to state that it had no official ties to any outside entity. To allay the concerns of hospital administrators, no repeating patients were allowed. Their acceptance of such programs was also helped by the presence and behavior of the A.A. volunteers who saved the hospital a lot of money, and saved their staff a lot of grief; they also clearly demonstrated that alcoholics could, in fact, become sober, caring, contributing members of society. This was especially evident as early treatment graduates returned to the ward as A.A. volunteers and sponsors.
