District 05: Public Information Report

Greetings District 5 GSRs, committee chairs, and officers. The PI committee met on 03/09/2020 and 04/06/2020.

Our committee took a moment to check in with committee members and see how everyone was coping with the "new normal". After sharing we opened the meeting with the following reading; "the spiritual principle service is behind A.A.'s Step Twelve: Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs." Step twelve is where we A.A.'s step away from ourselves and step up to help others.

The committee discussed our previous projects are on-hold and we needed to face a more urgent need. How do we inform the public that Alcoholics Anonymous is alive and well during these difficult times? The committee decided to create an email that can be send to organizations traditionally served by the PI committee. The PI committee will be reaching out to media outlets, churches and other forms of disseminating publicly how to contact A.A. and how to find a meeting.

Our committee is interested in collaborating with CPC and Treatment on also getting this information into the hands of the professional community as well.

Our committee has discussed the possibility of doing a "virtual workshop on anonymity in the digital age" as well. Our committee intends to meet weekly to address the rapidly changing and emerging needs of our fellowship and the still suffering Alcoholic.

The District 5 PI Committee brings forth a motion that all meetings from Western Wisconsin that wish to be put on our district website be listed. We ask this as District 14, District 6, and District 7 have no active website and during these unprecedented times the still suffering alcoholic has no place to turn for meetings other than online.

- Background, unreached Alcoholics continue to suffer all around us and District 5 is a situation to be helpful. Our meetings are widely accessible on www.district05.org and the A.A. meeting App. By adding any virtual meeting that is occurring in Districts 14,6, and 7 we could be carrying the message to a still suffering Alcoholic. This practice in not unprecedented and occurs in many districts where AA meetings are listed on their website to help carry the message. A small and section can be

added to our site that says similar to the following; Our neighboring communities have meetings as well......

The District 5 PI Committee brings forth a motion that each meeting be identified by their geographic location, open/closed, and if it is a specialty meeting to ensure we maintain the integrity of our meetings. Essentially, we ask that any registered groups or regularly listed meetings that have gone virtual be listed as they are on our regular District 5 directory.

- Background, The still suffering Alcoholic knows little to nothing about Alcoholics Anonymous and when access the list of virtual meetings through the District 5 Website the directory does not indicate if the meeting is open/closed, region it is in, and if it is a specialty meeting. Our district needs to ensure we help protect anonymity by labeling meetings as open or closed, guide people to any specialty meetings they may be incline to attend and that the still suffering alcoholic be able to identity a meeting from a geographic area he/she wishes to in order to begin to connect with other alcoholics that will be there for him/her when we are able to gather in person.
