#### Members' Views

## ...on STEP 3:

"Like all the remaining Steps, Step Three calls for affirmative action, for it is only by action that we can cut away the self-will which has always blocked the entry of God---or, if you like, a Higher Power---into our lives."

--- Twelve Steps and Twelve Traditions, pg. 34

With typical alcoholic thinking, I thought this step impossible for me because I didn't have an understanding of God---mostly just confusion about God, coupled with a stubborn refusal to be seen as wrong about anything. I leaped at this apparent "out" in the second half of the sentence, "as we understood Him," to dodge the call for an active decision in the first half. I needed guidance from A.A.'s collective wisdom to bring focus to this bedrock step.

As a child, I had been taught there was exactly one non-negotiable way to understand God. In A.A., it seems there are as many different understandings of the Higher Power as there are members. In *A New Pair of Glasses* Chuck C. said, "I like to use three words: Life, Good, God, which to me are synonymous words." Another member, Bob D., who often is quite blunt in his approach to recovery, said that Step Three is the means by which we "fire the jerk who has been running our life into the ground." I like that!

The Big Book, of course, provided me with two really significant road signs to Step Three. The first one was the scene at Bill W.'s kitchen table when Ebby T. asked Bill, "Why don't you choose your own conception of God?" Much like Bill, my old ideas, arguments and grudges against religion couldn't stand up to that challenge. Ebby took the focus off of anyone else's idea of God and laid the issue squarely in my lap. The second quote from the Big Book that made a big impact on my struggle with Step Three is Herbert Spencer's admonition against closed-mindedness on page 568, "...contempt prior to investigation." Taken together, these two quotes pointed me in the right direction: Finding my Higher Power is not a process of addition---it is not something I try to add to my daily life---it is a process of removal---as I am able to strip away some of the self-will that is blocking me from the needed power, that power can flow into me. So the affirmative action taken in Step Three and those that follow help me to uncover, discover, and discard the old ideas, the flaws in my character that are defense mechanisms I once needed to prop up a life run by self-will.

With new-found open-mindedness, liberated by A.A.'s near total lack of dogma, I have been able to make Step 3 the cornerstone of my daily program of recovery. Today I know there is no problem in life that I cannot make much worse by trying to conquer it by my own will. Step 3 has opened for me the way to contented sobriety.

#### ...on TRADITION #3:

"We just want to be sure that you get the same great chance for sobriety that we've had. So you're an A.A. member the minute you declare yourself."

--- Twelve Steps and Twelve Traditions, p.139

In this essay on Tradition 3, Bill W. acknowledged the fear-based intolerance of many early groups that sought to protect A.A. from people who, in many respects, were very much like me. Looking back to those early times, it is remarkable how rapidly A.A. moved from restrictive membership regulations to the adoption of this tradition. "Who dared to be judge, jury, and executioner of his own sick brother?" The history of A.A. traces a path toward inclusiveness and away from exclusiveness.

Relatively few of the A.A. newcomers I meet today identify themselves as what used to be called 'pure alcoholics.' For most, it is a matter of alcohol AND some other substances. Many, in fact, admit that it was addiction to one or another illegal drug that finally led them to seek help. For me, it was alcohol that brought me to my knees. When some are asked their 'drug of choice,' they may reply as I once did, "What've you got?"

In many towns and rural areas, A.A. is still the only local source of recovery help.

If these folks stay in A.A. long enough, they may come to understand that the condition we call alcoholism can apply to them, as well. Like all other newcomers, once a few cracks are made in their 'terminal uniqueness,' they begin to see how we are very much alike: Our 'what it was like' stories differ in the details, while our 'solution' stories are remarkably similar. And as with all newcomers, we seek to emphasize our commonalities, rather than let them seize upon some minor perceived difference as an excuse that can lead them right back out the door.

I am well aware there are some differences between addiction to alcohol and addiction to some other substances. We alcoholics are addicted to a substance which, for well over 90% of the population, is not physically addictive. Conversely, virtually anyone who uses heroin for any length of time will develop a physical addiction to it. An important question facing all newcomers is whether they have a purely physical addiction that can be solved by the detox and withdrawal process, or if they also are mentally and spiritually unwell, as I was.

I have been asked how I, as a recovered alcoholic, can function as a sponsor for newcomers whose addiction to drugs brought them seek help in A.A. My reply is simply that the sponsor/sponsee relationship need not entail a debate about chemistry at all. Powerlessness is powerlessness; spiritual awakening is spiritual awakening. Once we start to focus on the solution, which we do almost immediately, chemical preference is largely irrelevant. Only our first Step even mentions alcohol.

Some A.A.'s are uncomfortable with drug addict newcomers, as their use of illegal drugs is, by definition, criminal behavior. I would remind these members that the first 100 A.A.'s did the bulk of their drinking during the Prohibition era, when it was illegal to produce or sell alcoholic beverages. Generally, each of the first 100 "had to know someone" in order to obtain their booze, exactly like today's users of illegal street drugs.

My Big Book tells me that "bottles were only a symbol" of my problem; I see syringes and pipes as likely symbols of the very same spiritual malady. As an alcoholic, I believe I cannot honestly claim sobriety while using any mood-

altering or mind-altering substances; these folks desire to do the same, including abstinence from alcohol. We all seek to live sober in the A.A. solution.
